Signs and Symptoms of Exposure: Severe exposure may cause nausea, pulmonary irritation, loss of consciousness. May be fatal if swallowed. Direct contact with eyes causes redness, pain, conjunctivitis, and with severe exposure, possible cornea damage.			
Medical Conditions Generally Aggravated by Exposure:	Vapors may cause pulmonary irritation and redness of eyes. Prolonged contact with skin may cause reddening.		
Emergency and First Aid Procedures: Ingestion – Induce vomiting, with tsp salt in glass of water. Repeat. Eye Contact – Rinse immediately with water for 15 minutes. Inhalation: Remove to fresh air, give oxygen or artificial respiration.			

Section VII - Precautions for Safe Handling and Use

Steps to Be Taken in Case Material is Released or Spilled: Confine spilled material and absorb with sand, sawdust, earth or other available solids. Place in suitable container. Neutralize with soda ash and flush with water. Call (800) 424-9346 if spill is a reportable quantity. Rinse minor spills into sewer if permitted by federal, state, and local regulations.
Waste Disposal Method: Dispose of in compliance with federal, state, and local regulations.
Precautions to Be taken in Handling and Storing: Keep away from eyes. Avoid contact with skin and clothing. Wash skin that contacted material with soap and water. Avoid breathing mist or vapor. Use only with adequate ventilation.
Other Precautions: Do not use or store near heat or open flame. Store in plastic containers. Provide safety showers and eye wash stations. Personnel handling Formaldehyde must be trained in its use and for emergencies.
